# **POLICY DIRECTIVE**

---

**PURPOSE:**

To provide policy and procedure ensuring the Division of Corrections and Rehabilitation strives to follow nationally recognized standards and best practices in the field of adult and juvenile corrections.

**REFERENCE:**

WV Code §§15A-3-1; and 49-2-903.

**RESPONSIBILITY:**

No additional written instructions on this subject are required.

**CANCELLATION:**

Any previous written instruction on the subject including DCR Policy Directive 101.01, dated 02 August 2023.

**APPLICABILITY:**

All facilities and work units within the Division of Corrections and Rehabilitation (DCR). This Policy is available for general distribution.

**POLICY:**

- I. The Division of Corrections and Rehabilitation (DCR) maintains high standards and is committed to adhering to the standards and/or expected practices of:

- A. American Correctional Association (ACA)
- B. National Commission on Correctional Health Care (NCCHC)
- C. Correctional Education Association (CEA)
- D. Center for Improving Youth Justice (CIYJ), formerly known as PbS – Bureau of Juvenile Services only.

II. **The American Correctional Association (ACA)** provides a professional organization for all individuals and groups, both public and private that share a common goal of improving the justice system. The DCR is committed to the goal of achieving ACA accreditation for all facilities and applicable work units and will continue taking steps towards that goal.

- A. ACA accreditation is intended to improve facility operations through adherence to clear standards relevant to all areas/operations of the facility, including safety, security, order, inmate/resident care, programs, justice, and administration.
- B. ACA performance-based standards and expected practices are based on valid, reliable research and exemplary correctional practice. Accreditation manuals cover all areas of correctional operation, including adult, juvenile, and community corrections as well as correctional training academies, industry programs, parole field services, and central administration offices.
- C. The facilities and work units of the DCR will follow the ACA performance-based standards and expected practices as follows:

- III. **The National Commission on Correctional Health Care (NCCHC)** is an independent organization whose mission is to improve the quality of health care in jails, prisons, and juvenile confinement facilities.
- A. The DCR maintains a contractual agreement for comprehensive medical and mental health services which requires the provider to meet or exceed NCCHC requirements.
  - B. Accreditation signals a constitutionally acceptable level of care for a facility's inmates or residents, which translates into improved health status, fewer grievances and

lawsuits, and reduced health risk to the community when incarcerated individuals are released.

- IV. The goals of the **Correctional Education Association (CEA)** include increasing public awareness of correctional education as an integral part of reentry and establishing benchmarks and standards to identify quality programming through an accreditation process.
- A. CEA's philosophy is that detained and adjudicated juvenile and adult students need to learn to reassess their values, goals, and priorities in life in a way that differs from their time prior to incarceration.
  - B. Acquiring personal, social, and technical skills are necessary for a successful and permanent reentry into society as productive citizens, parents, and coworkers.
- V. **Center for Improving Youth Justice (CIYJ)**, formerly known as PbS, is a data-driven improvement model grounded in research that challenges youth correction, detention, assessment and community-based facilities and agencies to treat all youths in custody as one of our own. CIYJ sets national performance-based standards of excellence to guide facility operations, services and programs to best serve youths, staff and families.
- A. The CIYJ state coordinator for DCR provides information and guidance when necessary and ensures a site coordinator is assigned if needed.
  - B. The site coordinator will:
    - 1. Assign a facilitator to conduct interviews, surveys, or other tasks as required.
    - 2. Ensure that all data is entered into the CIYJ system according to CIYJ timeframes; and
    - 3. Data reported is accurate based on information reported by the facility.
- VI. Superintendents, and work unit supervisors/directors as appropriate, whose facility or work unit is undergoing an audit or accreditation will ensure that all employees are informed of the process and cooperate as needed.
