	SUBJECT:	CONSULAR NOTIFICATON PROCESS

POLICY DIRECTIVE

PURPOSE:

To ensure the Division of Corrections and Rehabilitation complies with its legal obligation to extend appropriate consular services to *foreign nationals* arrested and detained in the United States.

REFERENCE:

1963 Vienna Convention on Consular Relations (VCCR); and United States Department of State Consular Notification and Access Manual, Fifth Edition, September 2018.

RESPONSIBILITY:

No additional written instructions on this subject are required.

CANCELLATION:

Any previous written instruction on the subject, including DOC Policy Directive 331.01, dated 01 October 2004.

APPLICABILITY:

All facilities within the Division of Corrections and Rehabilitation that have custody of adult inmates. This Policy is available for general distribution.

DEFINITIONS:

Foreign Nationals: For the purposes of this Policy, any person who is not a U.S. citizen, including those who have a resident alien registration card, more commonly known as a "green card."

<u>Consular Officer:</u> For the purposes of this Policy, an official of a foreign government accredited by the U.S. Department of State and authorized to provide assistance on behalf of that government to that government's citizens in another country.

POLICY:

- I. When *foreign nationals* from most countries are detained, they may, upon request, have their consular officers notified without delay of their arrest or detention, and may have their communications to their consular officers forwarded without delay. In addition, *foreign nationals* must be advised of this information without delay. For *foreign nationals* of some countries, consular officers <u>must</u> be notified of the arrest or detention of a *foreign national*, even if the *foreign national* does not request or want notification.
- II. Consular officers are entitled to communicate with and to have access to their nationals in detention, and to provide consular assistance to them, including arranging for legal representation.
- III. When a law enforcement officer or other government official becomes aware of the death, serious injury, or serious illness of *foreign national*, consular officers must be notified.
- IV. The flow chart of arrest or detention notification procedures (Attachment #1) shall be posted in booking and intake areas. Steps to follow when a *foreign national* is arrested or detained include:
 - A. Determine the *foreign national's* country or nationality, in the absence of other information, assume this is the county on whose passport or other travel document the *foreign national* is traveling.
 - B. If the *foreign national's* country is on the list of "mandatory notification" countries:
 - 1. Inform the detainee that he or she may communicate with the consulate, and that you <u>must</u> notify consulate of arrest/detention.
 - 2. Notify the nearest consulate **without delay**.
 - 3. Make record of notification in case file by filing an incident report. If notification occurred by fax or email, keep fax confirmation or sent email.
 - 4. Allow consular officers access to detainee if they subsequently request access.
 - C. If the *foreign national's* country is <u>not</u> on the list of "mandatory notification":
 - 1. Inform detainee, without delay, that he or she may have consulate notified of arrest/detention. Make a note in the case file by filing an incident report.
 - 2. If the detainee wants the consulate notified, notify nearest consulate without delay.

- a. Make record of notification in case file by filing an incident report. If notification occurred by fax or email, keep fax confirmation or sent email.
- b. Allow consular officers access to detainee if they subsequently request access.
- 3. If the detainee does <u>not</u> want the consulate notified, make a note in the case file by filing an incident report and do <u>NOT</u> inform the consulate.

Consular Notification Process

STATES OF AUTO

IN ALL CASES:

- Do not inform consulate about detainee's refugee or asylum status.
- Detainee may communicate with consular officer and may request consular access at any time (whether previously declined or not).

Consular officers may have access to detainee

 regardless of whether detainee requests it. Even if detainee does not want to be visited, consular officers may still have one face-to-face visit.
