

Annual PREA Report: Office of PREA Compliance

Reporting Period: 2023-2025

Status: 100% Compliance Maintained

I. Overview & Mission

The Office of PREA Compliance was formally established in January 2019 to ensure the safety, dignity, and oversight of all individuals within our care. Since its inception, our office has built a robust infrastructure for accountability, including the creation of a comprehensive PREA Manual, standardized policies, and streamlined procedures. To ensure data integrity, we developed an agency-wide system that captures required data and meets all requirements outlined in the Federal PREA Standards. Using a collaborative team approach, we assist facility PREA Compliance Managers (PCMs) in preparing for federal audits and maintaining a zero-tolerance culture.

II. Audit Status & Progress

Our commitment to excellence is reflected in our perfect audit record across all 36 facilities:

- Juvenile Centers (10): Entering their 5th audit cycle. All facilities found in full compliance with the last 4 cycles.
- Jails (10): Entering their 5th audit cycle. All facilities found in full compliance with the last 4 cycles.
- Prisons (16): On their 4th audit cycle. All facilities found in full compliance for the last 3 cycles.

The Office of PREA Compliance has also driven educational excellence by co-developing the DCR training curriculum and leading numerous PREA Academy and Central Office classes for staff and leadership.

III. Aggregate Data for years

The following data represents the findings of all PREA-related investigations conducted during the 2023-2025 reporting period for the WV Division of Corrections and Rehabilitation.

Staff & Contractor Accountability

The agency maintains a high level of scrutiny regarding professional boundaries. We conducted **386** investigations into Staff on Inmate Sexual Misconduct and Contractor on Inmate behavior.

- **Results:** 40 staff members and 21 contractors were substantiated for misconduct.
- **Action Taken:** All substantiated cases resulted in immediate removal from the facility and, where applicable, referral for criminal prosecution. These findings highlight the effectiveness of our detection methods and the strength of our zero-tolerance policy.

Inmate-on-Inmate/Resident-on-Resident Safety

With **689** total allegations processed regarding peer-on-peer abuse and harassment, our data indicates a "healthy" reporting environment. Inmates/Residents are actively utilizing the reporting avenues taught in orientation and PREA awareness. While 100 cases were substantiated, the high number of unsubstantiated cases (461) demonstrates our commitment to investigating every report to its fullest extent to ensure resident safety.


V. Victim Support & Protection from Retaliation

The Office of PREA Compliance ensures that any individual involved in an allegation has immediate access to support services.

- **Advocacy:** We maintain partnerships with community-based rape crisis centers for confidential support.
- **Retaliation Monitoring:** We monitored all reporting residents for 90 days following an allegation. This year, only one allegation of retaliation was reported, which was promptly handled through formal disciplinary channels.

VI. Conclusion & Future Goals for the Prisons and Jails

As we enter the next audit cycles, our office remains dedicated to continuous improvement. We will continue to work with facility PCMs and investigators to ensure all complaints are addressed with integrity, and we will use our data to further refine staff training and facility supervision.
