Accomplishments



Staffing

On January 24, 2024, WV DCR had a 25% vacancy rate within its correctional officer staff. Through a robust recruiting strategy, including television ads, radio ads, social media, etc. and close work with our partners at the West Virginia Department of Commerce Office of Marketing and Communications, additional reductions of nearly 10% occurred as of October 25, 2024.

Notably, in May of 2024, Governor Jim Justice announced that the State of Emergency, which was put into effect in 2022 to address jail staffing shortages, had been lifted. West Virginia National Guard members who had been alleviating staffing shortages at adult and juvenile correctional and detention facilities have completed their mission and are out of all WV DCR facilities.

During FY24, a total of 515 individuals graduated from the Corrections Academy. This includes 455 Correctional Officers, 6 individuals who will work in Parole, 17 non-uniform staff that attended a residential Basic Training and 37 individuals attended the Modified Support Staff Academy, which is a virtual training program hosted by the employee's home facility.

Facility Updates

WV DCR identified and began work on major deferred maintenance projects, including roofing, paving and HVAC replacement at many facilities.

Salem Correctional Center created a unit to assist with overcrowding issues at North Central Regional Jail and Correctional Facility in January 2024 in an effort to house inmates awaiting legal intake as well as Parole violators awaiting final revocation hearings. To date, 224 inmates have been accommodated by this unit.

Since January, Salem Correction Center has transferred 881 inmates into its intake units to reduce their overcrowding and transferred 868 inmates out to fill prison beds.

Construction began on the new 120-bed facility at Anthony Correctional Center in Neola, West Virginia. This facility houses the youthful offender program for individuals aged 18-23 and will include new vocational courses and educational programs that will significantly improve success rates.

In April 2024, the South Central Regional Jail and Correctional Facility coordinated and hosted a Second Chance Job Fair for offenders who will be released within the next six months. This fair provided the opportunity to connect with employers and find a job after their release. Superintendent Thompson ensured each offender hand-wrote their resume to present to the businesses they were interested in.

Accomplishments

Programs and Services

Community Service

In FY24, eligible residents, offenders and parolees at 13 facilities completed 134,469 hours of community service. Community service hours can include community and highway cleanup, community beautification initiatives and more.

Policies and Audits

The Policy and Audit Section completed audits on most of WV DCR's 36 facilities to ensure compliance to current agency policy directives. The audit also ensures policies are compliant with directives from the American Correctional Association. In 2024, all publicly available WV DCR policies have been made available on dcr.wv.gov.

Prison Rape Elimination Act Compliance

All facilities within the agency, both adult and juvenile, achieved PREA (Prison Rape Elimination Act) compliance in 2024. The following PREA Audits were completed and received accreditation during FY24:

Recidivism Rates

In February 2024, WV DCR reviewed the effectiveness of the Residential Substance Abuse Therapy (RSAT) program and determined the initiative has a success rate of 32%. Between 2018 and 2023, 3,412 individuals graduated from the RSAT program. Of those, only 1,977 saw long-term success from the program.

With the rise in recidivism from program participants, the WV DCR determined a program change was necessary to more thoroughly assist incarcerated individuals struggling with addiction. In reviewing other states' programs and success rates, specifically Iowa and Michigan, with recidivism rates as low as 4.4%, WV DCR found that they were using Hazelden's A New Direction, the same curriculum that is used in the GOALS (Getting Over Addicted Lifestyles Successfully) program currently in use in West Virginia's jails. Where implemented in West Virginia, the GOALS program is showing recidivism rates of 5% in female inmates and 19% in males.

Implementation of the new program includes the creation and rollout of the Reentry Planner in West Virginia's prison facilities and the Community Resource Handbook in the state's Jails. Additional program implementation includes the Inside Out Program at St. Mary's Correctional Center and Jail, Parkersburg Correctional and Jail, and Huttonsville Correctional Center and Jail. This is an educational program with an innovative mentor-like approach tailored to facilitate dialogue across different points of view. It originated as a means of bringing college students and offenders together for a semester-long course held in a correctional setting.

Results for recidivism will be reviewed in April 2025.

Accomplishments

Criminal Investigation Unit

The Criminal Investigation Unit (CID) has 27 Investigators, including the Unit's Director, Deputy Director and two McDowell County employees.

From January through October 1, 2024, the CID Unit conducted 67 investigations at Juvenile Facilities, 272 at Jails, 206 at Prisons, and three involving Parole for a total of 548 cases. In many cases, members of the Investigations Unit worked closely with members of the West Virginia State Police in preparing these cases for prosecution. The CID Unit actively identifies and validates gang members incarcerated in the State of West Virginia and maintains a database of all those identified. At the time of an offender's release, this information is disseminated to law enforcement agencies within that area. Additionally, any law enforcement agency can query this database at any time through our investigators to obtain the status of potential or suspected gang members.

There are currently two CID Investigations stationed at the Fusion Center, and we are actively seeking to fill a third position. These investigators serve as the point of contact for law enforcement agencies nationwide that request inmate communications.

The CID Investigators coordinate efforts with any Fusion Center partner on requests relating to WV DCR information. Additionally, these Investigators are the point of contact for the Joint Terrorism Task Force (JTTF) for WV DCR relating to Terrorist ties as they pertain to any facility's safety and security.

In the same time period, the Investigations Division handled a total of 5,266 requests.

Community Partnerships

WV DCR and Glenville State University (GSU) launched a partnership aimed at providing eligible graduates of WV DCR's Basic Training programs with college-level course credit towards degrees in Criminal Justice at GSU.

Additionally, WV DCR and the University of Charleston (UC) announced a partnership to expand and enhance educational opportunities for the agency's employees.

Desert Waters is a program that helps correctional agencies and other public safety agencies counter corrections fatigue and other occupation-related fatigue in staff by cultivating a healthier workplace climate and a more engaged workforce through targeted skill-based training and research. Staff have received certified training and assisted with WV DCR staff's mental health.

South Central Regional Jail and Western Regional Jail have implemented agreements with Presteria, a local mental health provider, to provide a mobile van to assist released offenders with reentry services, including mental health, substance abuse treatment, employment opportunities, etc.

Pruntytown Correctional Center collaborated with the Department of Education and the Department of Motor Vehicles, which will assist inmates in taking their written test for driver's licenses.

Guardian RFID is a pilot program at North Central Regional Jail. This technology company's mission is to build and deploy systems of engagement and insight to protect America's Thin Gray Line. It uses inmate tracking and cell checks to cloud-based business and artificial intelligence, they digitally transform corrections facilities of every size. Results and reviews of this pilot have shown to be useful and effective.

Corrections Day at the Legislature

On February 12, 2024, the WV DCR organized Corrections Day at the West Virginia Legislature. Various officials from the West Virginia Department of Homeland Security and WV DCR attended the event. During the event, the WV DCR Recruiting Team discussed the recruiting initiatives and provided information for external participants regarding career opportunities available within the Division. Chaplain Ben Adams from St. Mary's Correctional Center said the prayer on the Senate floor before the start of the session, while Chaplain Daniel Arbogast from Huttonsville Correctional Center said the prayer on the House floor before the start of the House session. The Honor Guard, consisting of Major Richard Toney and Lt. Bobby Berry, presented the colors in the House.

Mock Prison Riot

The 27th Annual Mock Prison Riot held at the historic West Virginia Moundsville Penitentiary from April 28 to May 1, 2024, was a captivating event. The action-packed schedule included a skill competition and awards ceremony and a showcase of workshops, training scenarios, and cutting-edge technology demonstrations. This annual event drew participants from 18 countries and 34 states. The event concluded with a Charitable Golf Tournament at the picturesque Oglebay Golf Course. There was a dedication for the naming of the M.V. Coleman Memorial Building held during the Mock Riot this year.

Employee of the Year

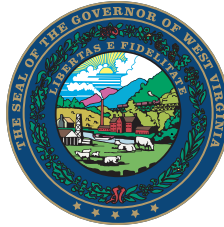
Lieutenant Sarah Dale from Anthony Correctional Center and Jail was named the agency's Employee of the Year.

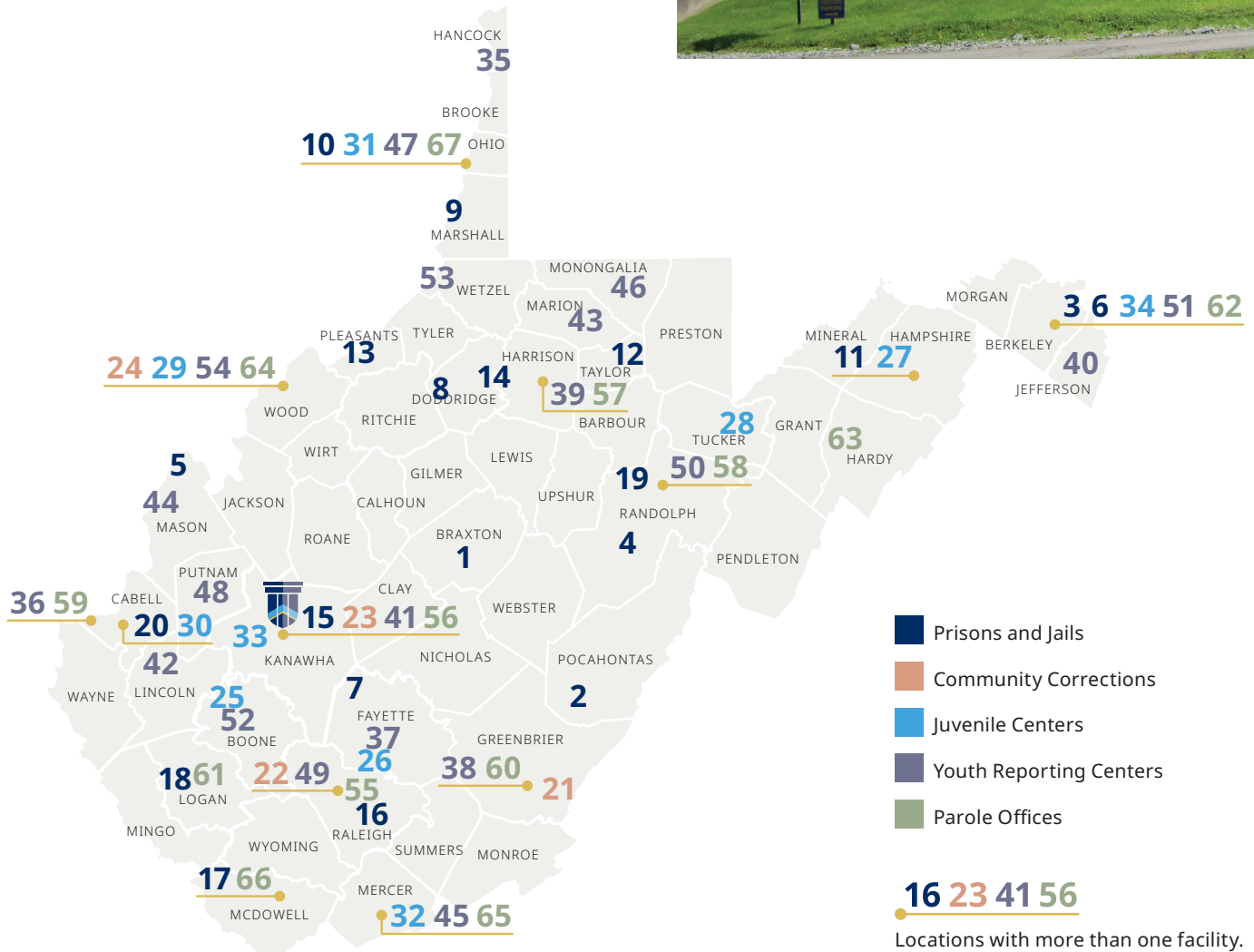

OFFICE OF THE COMMISSIONER

Commissioner

William Marshall was born in Point Pleasant and graduated from Wahama High School, Marshall University and the W.V. State Police Academy. Marshall began his State Police career in Huntington, where he was awarded the 1995 National Association of Police Organizations (NAPO) West Virginia Police Officer of the Year. He later received Honorable Mention for NAPO National Police Officer of the Year. After a tour of duty in Ripley, Marshall transferred to the Interstate Drug Interdiction Team. He was then selected to work on the W.V. Worker's Compensation Fraud Task Force. He also spent time assigned to the drug task forces in Charleston and Parkersburg.

Such distinguished service led to Marshall's selection to the IRS Criminal Investigation Division's Fraud Task Force, working out of the U.S. Attorney's Office for the Southern District of West Virginia in Charleston. While there, he received commendations for outstanding investigative work. He also received a deputation from the U.S. Marshal's Service. Marshall was promoted to Sgt. in 2006 and named Commander of the Pleasants County Detachment. He then served as Commander of the Wood County Detachment before being selected as the Deputy Director of Traffic Records at State Police Headquarters, working with the Governor's Highway Safety Program.

In 2010, Marshall returned to Wood County and resumed command there until the conclusion of his career in July 2017. He retired with more than 25 years of service with the West Virginia State Police. Following his retirement, Military Affairs and Public Safety Cabinet Secretary, Jeff Sandy, chose Marshall as the Cabinet Department's first Director of Corrections Investigations. It was while performing those duties that Governor Jim Justice appointed Marshall as Director of the former legacy agency, Division of Juvenile Services. Under the newly formed Division of Corrections and Rehabilitation, he served as Assistant Commissioner of the Bureau of Juvenile Services until his appointment by Governor Justice in January 2023, as the Commissioner of WV Division of Corrections and Rehabilitation.

Deputy Commissioner

Lance Yardley was named Deputy Commissioner for the West Virginia Division of Corrections and Rehabilitation in 2024. He began his career as a Correctional Officer at South Central Regional Jail. Throughout his more than 30-year career, he has served in various roles in multiple facilities across the state, including Central Regional Jail, Huttonsville Correctional Center and Pruntytown Correctional Center. Most recently, he served as the Chief of Institutional Operations for WVDCR.

Yardley, a West Virginia native, attended Potomac State College and Glenville State College.

The West Virginia Division of Corrections Director of Construction and Engineering is responsible for overseeing Corrections physical improvements in the facilities throughout the state.

Correctional Healthcare

This department serves as the WVDCR's liaison with health care vendors. Medical Services participates in assessments, planning, implementation and evaluation of policy and practice throughout the system.

General Counsel

Sean Francisco was hired as General Counsel for the West Virginia Division of Corrections and Rehabilitation in April of 2024. Francisco is a West Virginia native who earned his undergraduate degree from West Virginia University. Sean then went to law school and graduated from the University of Baltimore School of Law. He clerked for a short time for Judge Lawrence Robert Daniels of the Baltimore County Circuit Court. He also worked in the law office of Timothy A. Dachille and Associates. Francisco then returned home to West Virginia where he went to work as an assistant prosecuting attorney in the Wood County Prosecuting Attorney's Office. He was an assistant prosecuting attorney for over 16 years. During this same timeframe he acted as Assistant City Attorney for the City of Parkersburg for three years. Sean left the Wood County Prosecuting Attorney's Office to act as General Counsel and Human Resources Director for the Wood County Board of Education. After three years of service Sean left the Board of Education and joined the law firm of Jan Dils Attorneys at Law for a brief time. Prior to joining WVDCR, Sean operated his own legal practice; traveling the State of West Virginia, litigating a variety of cases. Sean has served on the West Virginia State Bar Board of Governors, the West Virginia Office of Disciplinary Counsel Lawyer Disciplinary Board Hearing Panel, President of the Wood County Bar Association, as well as previously serving and continuing to serve on numerous boards of community foundations and groups. Sean is happy to be a part of the WVDCR family.

Professional Standards and Compliance Assistant Commissioner



James Stout was named Assistant Commissioner of Professional Standards and Compliance in 2023. In January 1994, Stout began his professional career with the State Police and served multiple roles in the department. As a trooper, Stout was runner-up to receive the West Virginia Trooper of the Year Award twice. Stout served thirteen times as a Field Training Officer, which allowed him to expand upon his leadership and managerial skills. Stout served as a Sniper/Observer for ten years in the West Virginia State Police and with the Ritchie County Eradication and Crisis Response Team (R.E.A.C.T). He also served as a Hostage Negotiator for six years and went on to serve in upper-level management, ultimately being promoted to the rank of Captain. He ended his career with the West Virginia State Police in February 2019 after over 25 years of honorable service.

Inmate Population 2001-2023

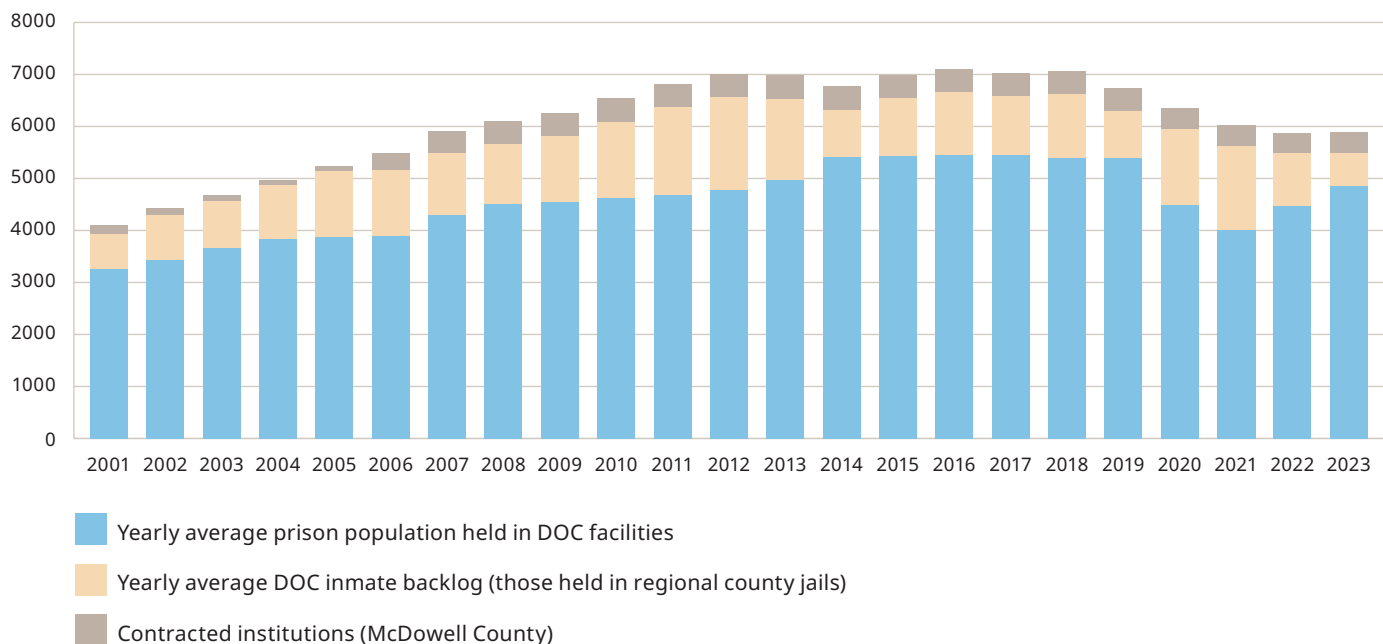
The table to the right and the chart below shows the total average sentenced inmate population in WV DCR institutions and the total average sentenced inmate population that have been committed to the WV DCR, but were awaiting prison space in county/ regional jails during the past 23 years. During that period, the total inmate population for WV DCR has increased by a total of 1,785 inmates.

Inmates that were committed to the WV DCR but were waiting in county/ regional jails for bed space in WV DCR facilities have decreased to a record low of 624 in 2023 from a high of 1,782 in 2012.

The WV DCR also houses inmates in the McDowell County Correctional Center on a per diem contract basis; this population is represented in the “Contracted” column. This segment has increased by 228 inmates in the last 23 years.

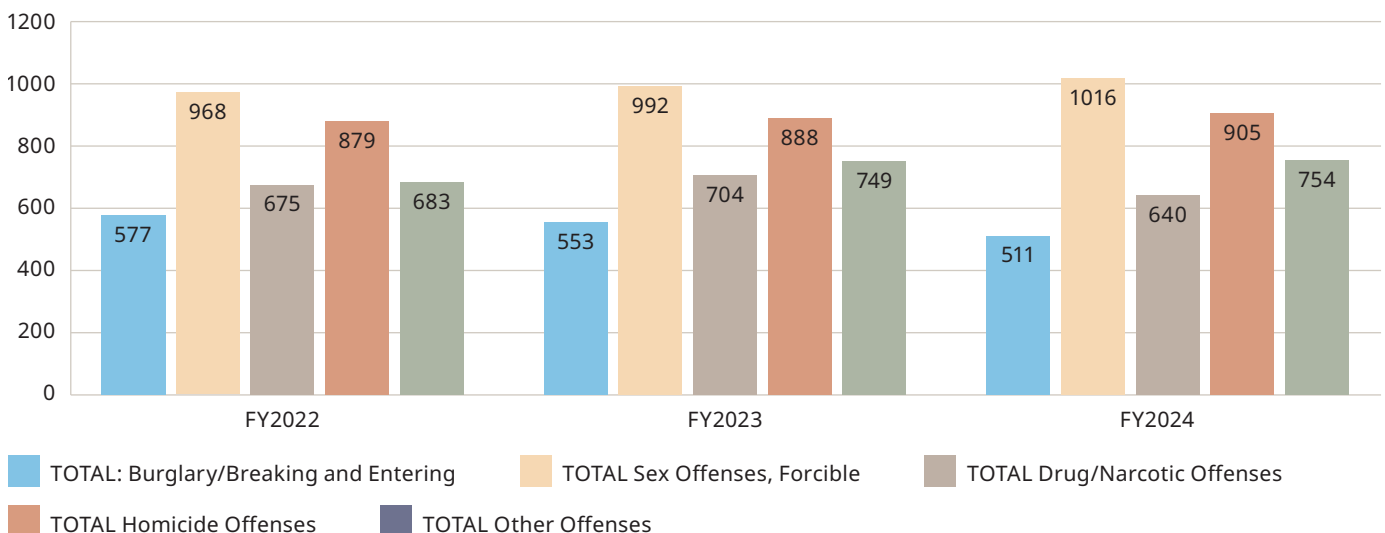

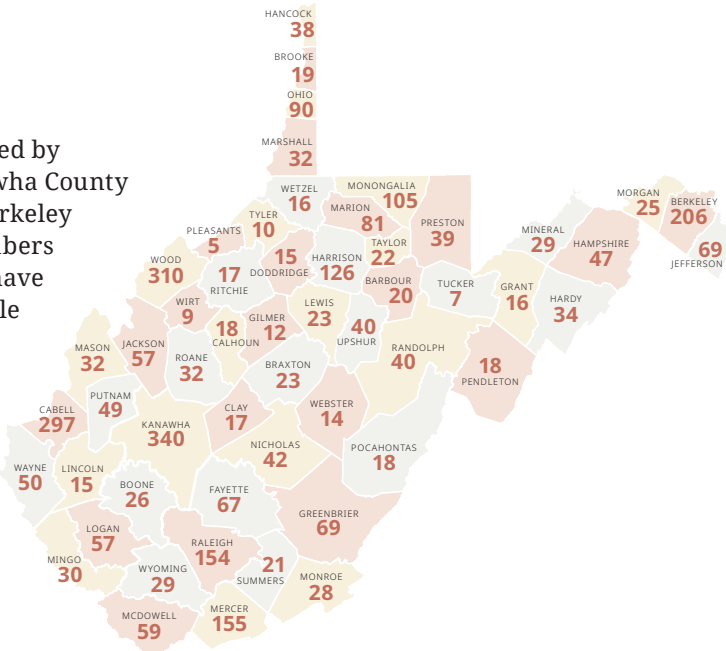

Number of Clients Supervised

The map at right shows the number of clients supervised by Parole Services, by county at the end of FY 2024. Kanawha County had the highest caseload, followed by Wood, Cabell, Berkeley and Mercer Counties. Some reasons for these high numbers are the fact that Kanawha, Wood and Cabell Counties have high populations compared to the rest of the State, while Berkeley borders other states and supervises a large number of interstate compact cases.

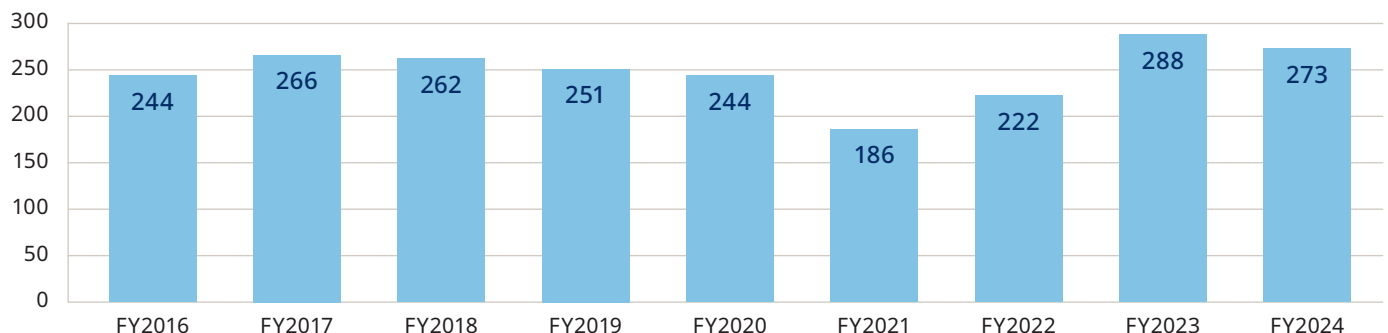

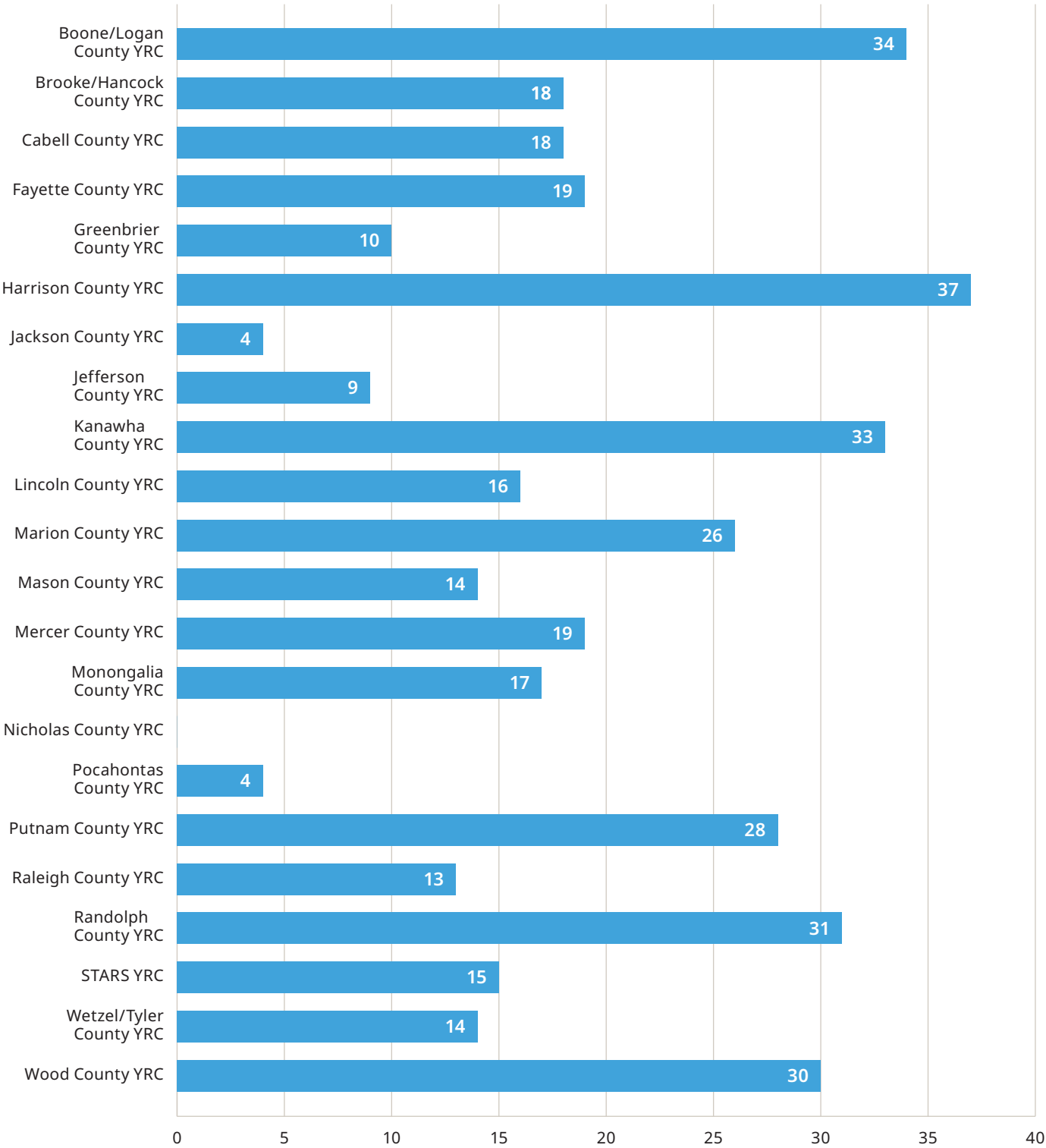

INTERGOVERNMENTAL AFFAIRS

Assistant Commissioner

David Farmer began his career with the WV Regional Jail Authority in February 2002 as the Director of Inmate services at the South Central Regional Jail in Charleston, WV. He later became the Administrator of the Southwestern Regional Jail in Logan, WV in December of 2011 where he remained until being named Director of the Academy/ Deputy Chief of Operations in August 2014. In June of 2015, Farmer was selected as the Executive Director of the Regional Jail and Correctional Facility Authority until the consolidation of the state's correctional agencies in July of 2018. Farmer was then appointed as an Assistant Commissioner of the Intergovernmental Affairs Bureau where he now oversees Constituent services, Victims Services, Inmate Grievance appeals, Correctional Industries and the WV Division of Corrections and Rehabilitation Corrections Academy.

Victims Services

The Victims Services Program offers direct services to victims of crime in all 55 counties in West Virginia for DCR. Carla Shirey is the Victim Services Specialist and provides services to victims by registering them in the OIS database and assisting them with the West Virginia Victims Notification Everyday (VINE) notification program. Registration is by phone, email, TTY, SMR text, and by using the VINE app. New VINE registration totals for FY 2024 were 7,374. During FY 2024, services were provided to more than 380 Victims of Crime, assisted with 200 parole hearings and 169 survivors, or family members of homicide.
